Harry Weissman – Assessor

Mr. Weissman provided reports showing trends from the state and sales analysis Ellicottville is on track to have a 99% equalization rate. He said the State may waive the need for senior exemption renewals. He is not planning on doing a massive update in 2021 because this has not been a normal year, sales have been much higher and sale prices may not be a true indication of assessed value. He will be looking at an update in 2022.

Gary Palumbo – Town Planner

- Assisting Mr. Slotman with documenting vouchers/payments to resubmit payment request to the State for LGE Grant.

- Working on updating the Zoning Book to include new amendments.

-Attended County Supervisors' meeting which addressed Farmland Protection. The NYS Dept. of Ag and Markets will be offering a \$25,000 Grant. He will do more research to see if the cost is worth additional benefit to support agricultural uses in the Town.

- Attended a seminar by State Emergency Services. FEMA will reimburse COVID related expenses related to health care, medical staff, PPE, food distribution, signage and law enforcement extra cost. Not sure if the Town would have any eligible expenses.

- The proposed Solar Farm project on Sommerville Valley is waiting to see what the PILOT and HOST agreements will look like before they move forward.

• OIC Auge - Police Department

A solar powered radar traffic sign has been ordered. The Village DPW will help put it in place and move it to different locations as warranted. The display can be controlled by a phone app.

• Ben Slotman – Engineering Department

- Building Department New Truck

Building Inspector, Kelly Fredrickson, obtained 5 quotes for a new truck for the Building Department. The Town budgeted for it in the 2021 budget. He is suggesting that the Town buy the 2020 Silverado V8 because it is available now and the resale value of a V8 will be higher than a V6. The Water Department would like to use the current truck for the time being so the workers can remain isolated from each other per Covid protocol.

- Engineering Report

- The LGE payment application is being revised in its entirety to be submitted.

- Wendel's Proposal for GIS service has been renewed for 2021. The Engineering Department is working with them to provided training.

- Valley Village additional test holes have been completed
- Annual training for Sexual Harassment has begun.
- SAM Grant DASNY is working through the final approval process
- Water Department received new meter reading equipment.

- Water rates review is ongoing. One issue that Mr. Slotman found is that there are 2160 parcels in the water district but only 1963 water accounts. Another is that water usage has been down. Supervisor McAndrew and Councilman Crowley will meet with Mr. Slotman at 4:00pm on January 7th to discuss water rates.

- CPL is working on the Water Project. They have drawn up a proposal and would like the Town to sign it. The Board would like to see it first.
