Update on Morrisville Waste Water School – Ben Slotman stated that he received another certification that he needs for final schooling. At the end of June he and Zack Golley will be attending another round.

COVID19 update – Mayor Burrell stated that the governor announced new policies to take place tomorrow. Village employees are not all vaccinated. How do we continue with the policy in place? At this time if you have been vaccinated we no longer have to wear a mask. What do we want to do moving forward? Ben is trying to get guidance to change our policy. Time to relax and if 2 guys are both vaccinated should be able to ride in the same truck. Ms. Croft added in her opinion the people that have been vaccinated should be able to be in the same truck without masks. Mr. Bush stated that it is complicated being employees that are not vaccinated is the Villages budget in jeopardy. How do we protect our budget? Mr. Lowes stated that we need to follow the rules from the governor and guidelines. He is all for starting to relax the rules when it's applicable. Has spoken with some employees and they want to get back to normal. He feels the mask signs in the Village can come down. Mr. Stanton stated incorporated guidelines by reference only go to people who are vaccinated. Issues with asking people if they have been vaccinated should be a reasonable question to ask. We are within out rights to ask the question. Should we have a photocopy in the file? Mr. Stanton thinks that is within reason. Mr. Imhoff agrees with all. Those who chose not to be vaccinated still need to wear a mask and fill out the health assessment form. Mr. Slotman is going to work on the policy.

Mayor Burrell stated that he would like to go back to normal and have in person meetings. We can spread out and if you are not vaccinated you must wear a mask. The town is going back to meetings at the town center stated Mr. Slotman.

Parks – Mr. Lowes stated that the ball fields and Dog Park look terrific. The school asked about the fireman's field and would like to see if the village could aerate, topsoil and seed the soccer field. Is it the fireman's responsibility? It does belong to the joint fire district stated Mayor Burrell. We are fine with helping and doing the mowing. Any major work being the property is not ours for doing heavy work

should be looked into by the fire commission. Mr. Lowes stated that he will bring it to the fire commission at this week's meeting. ECS students use the field.

Beautification – Mr. Lowes stated that the sign above the Village and Town hall needs to be restored.

Sidewalks - the project started this week on the new sidewalk on Mill Street to McKinley and should be finished by the end of the month.

Work is going to happen on 17 Elizabeth Street, two new driveways and replacing some sidewalk. Mr. Slotman stated that they are getting a plan together and working on details. This process will cost us for the concrete only.
