Call meeting to order:

Supervisor McAndrew called the meeting to order at 6:00pm and led the Pledge to the Flag.

Public Hearings

 Proposed Local Law No. 2 - 2020 Allowing the Town of Ellicottville to "Opt Out" of certain "Commercial, Business and Industrial Exemptions" permitted under NY RPTL-485b

Supervisor McAndrew opened the public hearing on Local Law No. 2 - 2020

Corey Wiktor, Executive Director of the Catt. Co. IDA, explained that under RPTL 485-b the Assessor can grant an exemption on properties on which a combination of residential and commercial construction work is performed to create a building used for mixed residential and commercial purposes. For such properties, 100% of the base amount attributable to the construction work is exempt during the first 8 years of the exemption, 80% is exempt in the 9th year, 60% the 10th, 40% the 11th and 20% the 12th year. He said the intent of the exemption is to encourage new investment and improvement of properties.

Assessor Weissman said that opting out of RPTL-485b maybe unnecessary. The tax abatement would be insignificant to the Town and the exemption is unlikely to be used. He recommended leaving it in place.

Motion by Mr. Hinman and second by Mr. Zerfas to close the public hearing. All Ayes. Carried.

 Proposed Local Law No. 3 - 2020 "Zoning Amendment for the Regulation of Solar Energy Systems"

Supervisor McAndrew opened the public hearing on Local Law No. 3 - 2020 "

Gary Palumbo reviewed the changes made to the Solar Zoning Amendment since the public hearing in November and which took into account the public and Town Board suggestions. Definitions were added and Land Use Tables were clarified to better protect the Water/Sewer districts. A section was added requiring Planning Board review for changes to output, footprint, height of solar panels and other modifications. Setback requirements were increased as was minimum lot size. Re-vegetation and avoidance of steep slopes were addressed, as well as fencing. Solar Farms will be required to have a Visual Impact Assessment. Inspection fees were added. The changes also give the Town negotiating power for PILOT's.

Joel Santistebon of Ecogy Energy emphasized that Solar Farms would benefit the community. He was concerned that not being able to build on a site that has more than a 15% slope is very constraining due to the nature of the landscape in the Ellicottville area. He also said that the 500' setback requirement is too restrictive.

It was explained that the steeper the slope, the harder it is to conceal the solar panels, creating more of a visual impact. Also soil erosion and sedimentation need to be considered. The 500' setback was added to protect the value of adjacent properties.

Michael Schaffer, a property owner on Witch Hollow Rd., also believes that the 500' setback is too restrictive. He sits on the Planning Board in Wheatfield and their setback requirement is 100'. He thinks screening would protect the neighboring properties.

Mr. Zerfas emphasized that the Zoning Amendment was drafted to protect the interests of the Town and not any one project.

Brian Noble supports the 500' setback as being fair to both the developer and the neighbors.

Gabe Bialkowski, also of Witch Hollow, is in the process of developing WNY's largest vertical farm and was planning on using a solar field to power it. With the slope requirement, that will not be possible on the property. Mr. Palumbo said a special use permit may be an option.

Motion by Mr. Hinman and second by Mr. Zerfas to close the public hearing. All Ayes. Carried.

Niles Pierson – Engineering Department

Monthly Report

- Second reimbursement request (\$233,860.40) was sent to NYS LGE branch for the Engineering Grant in November. Mr. Pierson recently heard from the administrator, Chris Grant, and is providing further documentation.

-Design Proposals were received from Clark Patterson Lee and Wendel for the HVAC project at the Town Center. Clark Patterson Lee proposed \$39,000 to design the plan to add a boiler and air conditioning, \$10,500 for the boiler system, alone. They also would research grants to pay for the heating system. Wendel's proposal was \$71,000 for boiler and air conditioning and \$31,000 for the boiler system alone. The estimated cost of construction for the boiler system would be between \$100,000 and \$150,000. If the air conditioning system was added, the cost would rise to \$400,000 to \$500,000. It was pointed out that it would be unlikely to obtain any grant money for an air conditioning system. Mr. Pierson said that the current boiler system is close to 60 years old and only 60% efficient.

On motion by Mr. Hinman and second by Mr. Fitzpatrick the following resolution was:

Resolved that Clark Patterson Lee be retained to design the boiler/heating system for the Town Hall at the quoted price.

-Meetings were held regarding the Holiday Valley drainage design project. Work is anticipated to start this summer.

-A meeting with the Kerls and their lawyer was held to resolve the Trailer Park meter issue. An agreement is being drafted by Attorneys Moriarty and Stanton.

-Still waiting to get the signed Water IMA from the Town of Mansfield.

• Resolution Establishing Water System Capital Project Fund

ESTABLISH TOWN OF ELLICOTTVILLE WATER SYSTEM IMPROVEMENT CAPITAL PROJECT FUND AND AUTHORIZE INTER-FUND TRANSFERS

Motion by Mr. Crowley, second by Mr. Zerfas:

RESOLUTION TO ESTABLISH TOWN OF ELLICOTTVILE WATER SYSTEM IMPROVEMENT CAPITAL PROJECT FUND

WHEREAS, the Town of Ellicottville is undertaking a water system capital improvement project within the Town of Ellicottville Consolidated Water District No. 1, which will generally consist of (but not limited to) the installation of approximately 17,000 LF of water main along various roads in the District, electrical and various improvements to source wells and booster stations and the installation of storage tanks and other related site work, equipment, apparatus and other improvements and costs of financing incidental thereto; and

WHEREAS, the estimated maximum total project cost thereof is \$5,277,096, said costs to be financed through a \$2,277,096 loan agreement with the New York State Environmental Facilities Drinking Water State Revolving Loan Fund at 0% interest and a \$3,000,000 New York State Water Infrastructure Improvement Act (WIIA) grant.

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Ellicottville, New York that there is hereby established a capital project fund to be known as the "Town of Ellicottville Water System Improvement Capital Project Fund" (hereinafter "Capital Project Fund"). The purpose of this Fund is to account for and receive moneys from the above said loan and grant programs and to make pay invoices for authorized improvements and expenses made to improve the Town of Ellicottville Consolidated Water District No. 1.

FURTHER RESOLVED that the Town Board of the Town of Ellicottville does hereby grant the Town Supervisor, the Town's Chief Fiscal Officer, to make interfund loan transfers of funds to the Capital Project Fund in an amount not to exceed \$50,000 as may from time to time hereafter be necessary in anticipation of the receipt of said loan and grant funds, and be it

FURTHER RESOLVED that the moneys in the Capital Project Fund shall be kept in separate fund (H Fund) and be given a separate title according to the specific purpose for which it was created. The moneys in such fund shall be deposited into a bank account in one or more banks or trust companies designated in a manner provided by law as depositories of the funds of the Town, and be it

FURTHER RESOLVED that the Supervisor is hereby directed to deposit and secure the moneys of said Reserve Fund, including any transfers to or from such fund, in accordance with the provisions of Section 10 of the General Municipal Law. The Supervisor may invest the moneys in the Reserve Fund in the manner provided by section 11 of the General Municipal Law, and consistent with the investment policy of the Town of Ellicottville. Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue to and become part of the Capital Project financed with loan and

grant funds. The separate identity of the fund shall be maintained whether its assets consist of cash or investments, or both, and be it

FURTHER RESOLVED that an expenditure shall be made from the Capital Project Fund only by resolution of the Town Board and only for the specific capital improvement or specific items related to said project.
