Planner's Request – Zoning Officer

Planner Palumbo is requesting that the Town appoint him Zoning Enforcement Officer. His ability to process sign and zoning permits would increase the efficiency of the department. The Town's Zoning Law allows for a Zoning Official. Such a designation would not result in a change of hours worked or compensation. Although Mr. Palumbo believes the title to be an internal title, he was directed to check with Civil Service before next month's meeting.

Department Heads

- OIC Auge Police Department
- Police Vehicle 2016 Tahoe

The trade in value of the 2016 Tahoe is \$9500. OIC Auge said that would help off-set the cost of outfitting the new vehicle and save money in his equipment budget. He also pointed out that the vehicle has constantly had issues that have cost a lot of money for repairs. He is not sure the EVGV Ambulance Department would want to take on those expenses. Mr. Crowley pointed out that the vehicle could be beneficial to the Ambulance Department to store their AED, etc. They may not have the problems with it because the Ambulance Department would not use it as much as the Police Department did.

Radar

OIC Auge said that there are obstacles and permits that need to be obtained to put the radar sign on a State or County Highway. He is proposing setting it up on Maples Road for now pending approval by the County.

• Gary Palumbo – Town Planner

Mr. Palumbo reviewed his monthly report.

There are 3 Solar Companies still interested in constructing Solar Farms. There have been some issues with NYSEG relating to Substation upgrades. Currently, there are no formal applications.

Mr. Palumbo is working with the Planning Board on the Comprehensive Plan Annual Review. Recommendations will be presented in the next months.

He is working with the Highway Superintendent and Engineer on drafting Culvert NY Grant applications.

• Ben Slotman - Engineering Department

Monthly Report:

- WWTP Operations Course begins later this month.
- Mr. Slotman is proposing to advertise for an assistant engineer. He would like a full-time assistant but is looking for input from the Board. The Board advised that the Town is not in the position to hire a full-time assistant at this point and suggested he look for an intern.
- A meeting is scheduled with Bancorp for March 23rd.
- DOS is reviewing LGE application.
- Town Center Engineering Department is working on layout for the office space and gathering associated costs. The lighting was discussed.
- Highway Barn Trench Drain Reconstruction Project alternatives were discussed.
- Holihuts Water Connection project. An informational packet has been prepared to distribute to the HOA.
- Location of the proposed tanks was discussed. A title search and deeds need to be ordered for the Town reservoir. The existing access road is in bad shape. The best course of action to address access is being discussed with Mr. Northrup.
 - Tom Scharf Highway Department

There have been many repairs needed on the Department's trucks. Mr. Hinman and Mr. Zerfas looked at the floor drain issue. The new fuel pump system is up and working.

Mr. Scharf asked the Board to clarify policy that allows employees to leave for ambulance and fire calls. The Board emphasized that safety of the employees and public is the #1 priority. After that, the Highway Superintendent can use his discretion as to whether employees can answer calls during working hours.

Supervisor McAndrew asked Mr. Scharf if he thought the Town should still pursue use of the Canada Hill property for a refuse. Although Mr. Scharf said they still need a place to dump refuse, that site is no longer feasible.

Old Business

Valley Village

A meeting was held with Valley Village to discuss the proposed plan to grind the existing pavement and sub base into a reusable material to be used to shape the parking area. Valley Village was agreeable. Work on the design and costs are ongoing.

Revisions are being made but things are moving forward. There is a meeting scheduled.
