#### **Don Auge - Police Department**

OIC Auge reported that the police vehicles have all been disinfected at no cost to the Town. Face masks, shields, gloves and hand sanitizer have been provided to all officers. Officer Bouchard put together a binder outlining safety procedures. The department has stepped up patrol on the roads which have seasonal residents. Auge gave a "shout out" to his officers that are doing a great job under difficult circumstances.

# **Niles Pierson – Engineering Department**

- Monthly Report
- A meeting was held with Holiday Valley to discuss the proposed drainage design project. Work is scheduled to begin in the summer.
- WIIA Grant project a design meeting with Clark Patterson Lee was postponed due to the Covid19 pandemic.
- Mr. Pierson is working on a deed description for the parcel of land where the Village reservoir is so John Northrup can officially sign off on it. He is also drawing up property acquisition paperwork for the Upper Tank at Holimont.
  - Mr. Pierson has received a handful of calls about the new water rates.

The commercial meters at the Fire Hall, Inn at Holiday Valley and Holimont Main Lodge need to be replaced. The Fire Hall has agreed to pay for theirs. The other 2 will cost about \$7,000. The Board agreed that since the Village Sewer and Town Water both base their bills on metered usage, they should split the cost of the replacements. The IMA will be amended to reflect each municipalities responsibility.

### **Tom Scharf - Highway Department**

The Department has been working on a scaled back schedule, however they will resume a full schedule next week. They have been doing winter clean up and some plowing. They will begin crack sealing on Holiday Valley Road and then striping.

A problem has come up as to where to dispose of trees. The County will no longer accept tree waste with a diameter over 4" and lengths longer than 4'. One suggestion was to dig a hole and bury the debris. This would involve hiring an excavator and possible DEC permission. The other suggestion was to look into disposing in another county.

#### **New Business**

Ellicottville Championship Rodeo (John and Karen Kent) sent a letter announcing the plans for their annual Rodeo, July 2nd through July 5th. They have requested a Noise Permit until 1:00am.
