Supervisor's Meeting - Shared Services

The County Administrator, Jack Searles, presented the Shared Services plan which quantifies the services and documents the savings to the municipalities and county. The county has a software program that calculates the savings. This year, the State has a grant that will return 1/2 of the savings to the local government agencies. Although the process must be completed each year, the reimbursement through a grant is only for the first year. The next step is to have the Towns review the plan and return it to the county who will have a panel do a final review. After which, a vote will be held to approve it. The vote must pass with a majority from all of the Town Supervisors, Village/City Mayors and County Administrator.

The following bids were received for updating the Highway Barn's electrical system:

Gerwitz & McNeil - \$35,236.00 Electrical Services Systems Installation - \$25,135.00

The scope of the work involves replacing bulbs with LED bulbs and installing a 14' fan in the ceiling for much needed air circulation. ESSI would install ballast bypasses of all lights for an additional \$300.00. Mr. Pierson will double check this amount. Although this project will reduce the load on the conduits, more needs to be done.

Jed Lane/Sommerville Valley Culvert

Fabrication for the culvert is currently out for bid. Environmental permits have been applied for through the Soil and Water Conservation. The creek location is protected, therefore, work cannot start until after June 1st.

NYS DOT Update Curb Ramps

NYS DOT will be reconstructing multiple curb ramps throughout the Town. The work will affect two of the Town's water valve boxes at Aspen and Donlen Drive. The state will take responsibility for adjusting the height of the valve boxes during construction. This will be done at no cost to the Town.

WHEREAS, the State will provide for the reconstruction of the above-mentioned work, as shown on the contract plans relating to the above-mentioned project
