Don Auge - Police Department

Plate Reader

The plate reader was switched from one police vehicle to another in order to spread out the mileage between vehicles. It was done at minimal expense because all of the parts were transferable.

Auge is looking into buying a new police vehicle.by piggy backing the Town's purchase on a Chautauqua County order, thereby satisfying the State Bid requirement.

The Police Department will be sending an officer to radar training and a data master training school is coming up.

Loyd Hovey - Highway Department

Mr. Hovey updated the Board on the status of the Town roads and the work that is being done on the highway vehicles. He asked about buying a tire changer and was told if there is money left in the budget, he could order one.

Fuel Storage Roof

The money for the fuel storage roof is in the budget for 2016.

Peterbilt Truck

The sander will be put on the new Peterbilt truck. It cannot be inspected until the sander is on.

Drainage on Horn Hill

Drainage is a concern for a property owner on Horn Hill. It was determined that part of the problem is the run off caused by a neighbor's cement driveway. Mr. Hovey and Mr. Alianello will look into the issue.

Mark Alianello, PE – Engineering Department

East Tank

All paperwork has been submitted for the Empire State Development Grant and the Town hopes to receive the grant money by the end of the year.

Jackman Hill Tower Strobe Light

There have been several complaints about a bright strobe light that was recently installed on a tower on Jackman Hill Road. Mr. Alianello found there to be two towers, both with strobe lights. The one that seems to be the brightest is owned by the FAA. He is trying to find a contact for the towers so he can see why the strobe lights were installed and if they can be replaced with something less intrusive.

Middle Zone Water Loop

The Middle Zone Water Loop has been completed and the cost of the project was well under the original budgeted amount.

Harry Weissman - Assessor

Mr. Weissman reported that according to the County Assessor's Association, the state of Ellicottville's assessments is in good shape. He pointed out that Allegany budgeted for a \$147,000.00 reassessment project, whereas Ellicottville is able to keep assessments current, in house.

Old Business

Noise Law

The Noise Local Law was referred to the planning board for their input. Because the planning board has no jurisdiction to pass local laws, they elected not to give a formal opinion on the subject.

Since the wording in the current Noise Local Law does not specifically address hours of allowed noise on Saturdays, Ms. Moriarty was asked to update the law.

Personnel Files

Since some questions have been brought up as to who should have custody of personnel files, Mr. Burrell is asking that Ms. Moriarty research the subject.

Alarm Local Law

At last month's meeting Ms Moriarty was asked to find out why some Village properties are required to get an Alarm permit from the County. The answer seems to be that since the Town has its own Alarm Local Law, Town properties are exempt from the County Law, but Village properties are not.
